**COURSE PROVISIONS**

1. **Mansib Driving School** will provide a minimum of 24 hours of classroom instruction, 6 hours of behind-the-wheel (BTW) instruction, and 4 hours of observation time in a dual controlled automobile that is insured covering each student enrolled in the program. Classroom instruction must be a minimum of 3 weeks in length. BTW instruction shall not begin until the student has received a minimum of 4 hours of classroom instruction. BTW instruction must be completed no later than 3 weeks after the classroom instruction has been completed. Behind the wheel training is outside of classroom hours.

**TERMS**

1. The student must be at least 14 years & 8 months of age by the first scheduled day of class (verification of date of birth is required by copy of students Birth certificate in English, State ID or copy of a valid passport.). Student must bring a parent (Father/Mother) or a legal guardian who has a valid picture ID and at least 21 years old.
2. The parent or guardian agrees to all the terms and pay the amount of **(\$289.00)** Cash, Online, Debit or Credit card charges which need to be paid in 50% upon signing this contract and paid in full on or before the 1<sup>st</sup> class of the course begin. Deposit is not refundable except if the student withdraw, Cancel or rescheduled **48 hours** in advance. Another deposit will be required for a new class schedule or appointment.
3. Requirements to pass the course: *students must attend all classes in order to eligible for the state test.*
4. **The required score to pass the STATE TEST is 70%. Student will be given up to 2 additional attempt to pass the Test.**
5. To Replace a lost or Damaged Segment 1 Certificate Call the Office and pay \$25
6. **Mansib Driving School** May provide returnable or in addition material as book for teenage and adult program. There is a charge and student agrees to pay only when returnable item is damage, lost or missing. Or not returned in good condition will charge on each item up to **\$25.00.**
7. In the event of absent, tardy, missing driving training, or classroom instruction, student who has missed more than one day of the classroom instruction, must provide an E.R letter/doctors note/police report/parent or legal guardian excuse letter to make up for any missed assignments **The student is required to make up the same class session missed in a future segment 1 class. If the student missed their BTW driving training schedule time, they will need to reschedule for their driving training and pay a fee of \$30.00 an hour for road driving lesson if 24 hours advance notice is not given.**
8. Mansib Driving School Reserves the Right to update and change, Cancel, Reschedule or Modify any Classroom or BTW schedule with advance notice.

**REFUND POLICY**

If for any reason you decide to withdraw from the course before its completion, your refund will be based on the following:
