For a student to participate in segment 2, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a level 1 license, which has been held for not less than 3 continuous months.

**TERMS**

1. The parent or guardian agrees to all the terms pay the amount of (\$60.00) Cash, Online, Debit or Credit card charges which need to be paid in 50% upon signing this contract and paid in full on or before the 1<sup>st</sup> class of the course begin. Deposit is not refundable except if the student withdraw, Cancel or rescheduled 48 hours in advance. Another deposit will be required for a new class schedule or appointment.
2. Student must bring a parent (Father/Mother) or a legal guardian who has a valid picture ID and at least 21 years old
3. Requirements to pass the course: *students must attend all classes in order to eligible for the state test.*
4. **The required score to pass the STATE TEST is 70%. Student will be given up to 2 additional attempt to pass the Test.**
5. To Replace a lost or Damaged Segment 2 Certificate Call the Office and pay \$25
6. **Mansib Driving School** May provide returnable or in addition material as book for teenage and adult program. There is a charge and student agrees to pay only when returnable item is damage, lost or missing. Or not returned in good condition will charge on each item up to \$25.00.
7. In the event of absent, tardy or classroom instruction, student who has missed more than one day of the classroom instruction, must provide an E.R letter/doctors note/police report/parent or legal guardian excuse letter to make up for any missed assignments
8. Make up classes will be offered during the next available Segment 2 Class.

**REFUND POLICY**
